"For a while he refused; but later he (the unjust judge) said to himself, 'Though I have no fear of God and no respect for anyone, yet because this widow keeps bothering me, I will grant her justice..." Luke 18:4-5a, NRSV.

The parable of the widow and the unjust judge is as much about persistent prayer as it is about crying out for injustice. Holly Hearon, a religion author, states that the parable confidently asserts that if a judge, who regards neither God nor people with respect, will finally yield to the persistent pleading of a defenseless widow, then God, who desires good things for God's people will surely respond to our prayers.

Many voices are raised to God daily on the account of injustices in the world. Prayers made in time of need. God's "switchboard" has always been lit up. We can always pray and know that there is a listening God hearing our prayers. | Chairperson of the church council. This officer is the primary leader of |

| Recording secretary. This officer takes records minutes of all Council meetings, submits them for approval, then for print in the newsletter. The secretary may be a resource on past transactions of business from prior meetings, or years. (Currently Kelly Amunrud) |
| Treasurer. This officer works with collecting and dispersing funds. Overseeing fund balances and offerings, and paying vendors, and staff paychecks are among these duties. The treasurer reports on church finances at each Ad. Council monthly meeting. (Currently Tyler Kispert) |
| Staff-Parish Relations Committee chair. This committee oversees staff relations, conducts with other committee member(s) evaluations of staff and pastor, listens to concerns from and about staff or pastor. Evaluations are conducted twice per year. Parsonage relations to tenants also fall under this position. (Currently Beth Hanggi) |

Trustee chair. At least one trustee, who cares for the church and parsonage properties shall be on the Ad. Council. This trustee chair cares for the church building and parsonage house and their respective properties, addressing maintenance issues as they come up. (The whole Ad. Council has been acting as the trustees as there are no trustees at this time. We desire that the trustee chair position be filled.)





ADMINISTRATIVE COUNCIL

TUESDAY, SEPTEMBER 16, 2025 (REVISED)

ATTENDANCE: Chad Christensen (Pastor), Beth Hanggi (SPRC), Kelly Amunrud (Trust Fund), Lisa O'Neil (Ad Council Chairperson), Tyler Kispert (Treasurer), and Kathy Bartz.

MEETING: Lisa called the meeting to order and Pastor Chad opened the meeting with a prayer.

SECRETARY: The August Ad Council minutes were distributed. Motion was made to approve the minutes. Motion was seconded and approved.

TREASURER: Ênd of August balance \$16,434.18. (Set aside for parsonage \$5,755.46). Memorial fund end of August balance \$18,336.41.

Expenses/Future of the church: Tyler ran an excel spreadsheet that compares monthly expenses and incomes. From January through August 2025, we are currently coming up \$10,348 short with planned expenses. We had budgeted \$75,000 for 2025 but if expenses and giving continue we will have spent \$90,000 by December. Tyler will bring a detailed report next month to see if we can cut expenses anywhere.

TRUST FÛND: End of August balance \$92,8917.51.

Tuck and Point: Kelly and Lisa met with Benike. They are able to do the repairs within the estimate of \$47,100. They are brick matching and once the brick is here they will notify Kelly to start the project which should take about 2 weeks. Will invoice once they are done.

Mold: Kelly met with Paul Davis Restoration 507-330-6530. There is surface mold so it is something they can clean, treat, Kilz, and then repaint. The quote was \$2500-\$3500. Kelly will verify that cost includes everything and then we will have them come after the brick exterior job is finished to avoid further damage if it rains. Motion was made to use Trust Funds for this project. Motion was seconded and approved. They also noted some bricks in the Sunday school rooms on the East wall that have deteriorated but it is not mold. Will look at this at a later date.

TRUSTEES:

Light: There is a light in the fellowship hall that needs to be replaced. Lisa will work to find someone to replace it. Broz electric was mentioned. Pastor Chad mentioned there may also be a light in the entry that needs attention too as it's

SPRC: Pastor Chad, Beth, and Doris met for Pastor's annual review. The council received an email from Janet Bugarin asking to have the basement cleaning taken off her job duties. Suggestions were made on how to proceed including hiring someone vs asking if she would do just special tasks. Will review.

Parsonage: Discussion was held about raising the rent at the parsonage due to the upgrades, rising costs, etc. Kelly and Beth will draft a letter to send to the renters that effective January 1, 2026 rent will increase to \$1,200 and be revisited in six months with a possible increase again on July 1, 2026.

PASTOR: (See page 2) Confirmation will be two Wednesday's a month as there is one confirmand. Discussion about suggestions for worship services.

OTHER BUSINESS:

- October Community Dinner: The meal will be soup, sandwiches, and dessert.
- Church windows: Discussion about church windows online vs desktop as the treasurer's computer doesn't work well. We discussed options and will readdress in December when the payment is due again to decide on purchasing online or a new computer. The online version is \$1428/year. Memorial money could be used.
- Trinity rally: An invitation to the Klevos farm on 9/21 was extended to our church to attend.
- CCLI license: This was tabled under next month.
- Sunday school: Options were discussed due to the low numbers such as a Wednesday night service or a combination of Sun/Wed. Sunday school will meet on Sundays in October to give more time for Lisa and Lois to discuss options.
- Church future: Discussions were held about what brings us joy, what feeds our souls in our current missions, what can we take a break from. Will continue this discussion.
- Trunk or Treat: We have been asked if we would like to do a trunk or treat at Green Shack on October 26 th . There was no interest.
- Ad council: As we have no nominations committee and we are coming up on another year, it was brought up that we give an invitation to church members to take their turn on ad council in some capacity with a two year term limit.
